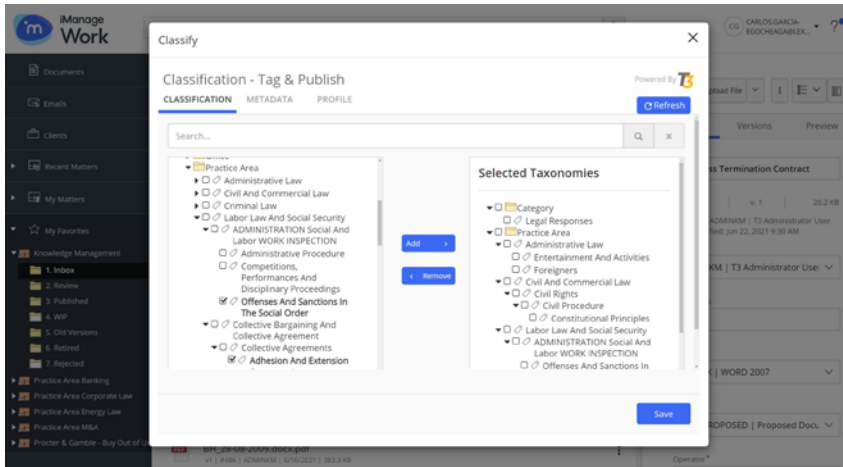

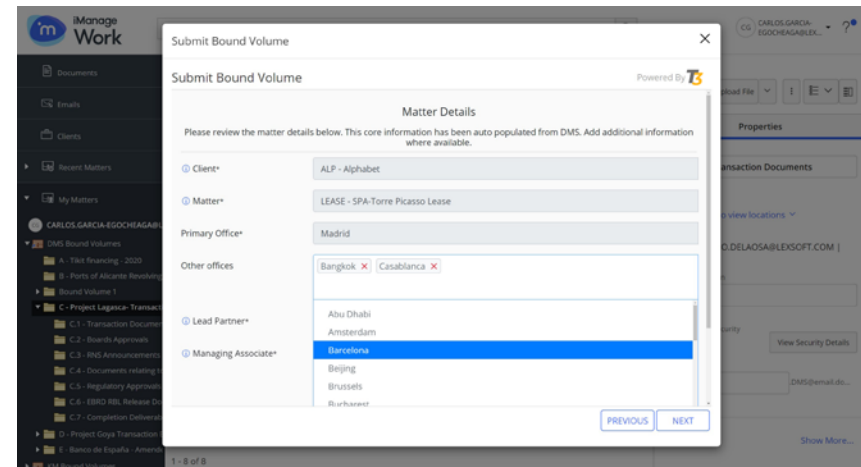


## User friendly

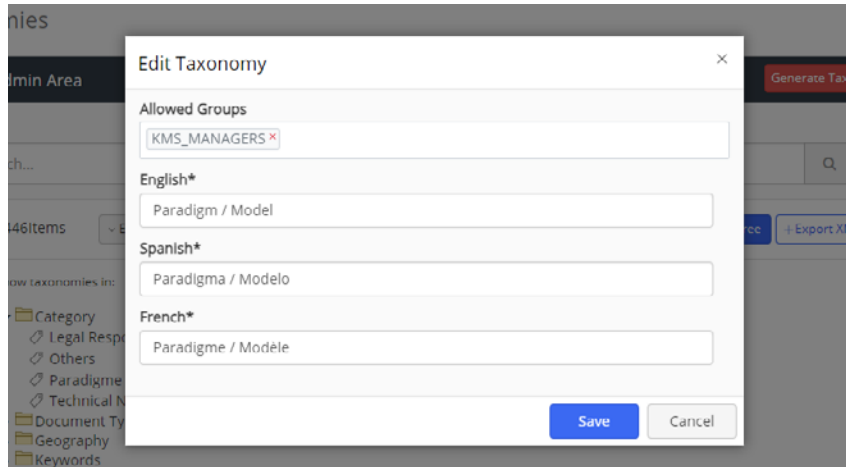
## Bound Volumes/Deals

## Data security

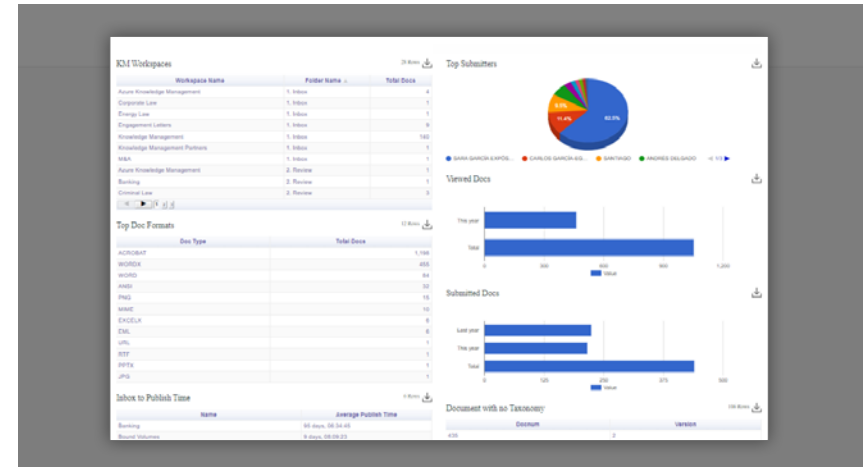
